FOUNDER/ E.D: A MOTHER'S LOVE INITIATIVE

THE 2-DAY STRATEGIC/ IDEATION MEETING ON THE HURRIED CHILD PROJECT IN LAGOS STATE (JULY $29^{\rm TH}$ & $20^{\rm TH}$ 2023)



A two-day strategic meeting was convened on July 19th and 20th, 2023, at the Lagos State Ministry of Education's conference room in Alausa, Ikeja, Lagos. The purpose of the meeting was to define roles, establish a comprehensive strategy, allocate resources, and ensure the sustainability of a project aimed at raising awareness about the Hurried Child Syndrome and providing support to affected individuals and families.

Key stakeholders from various government ministries including Education, Health, Youth and Social Development, Women's Affairs and Poverty Alleviation, as well as the State Universal Basic Education Board, and the Domestic and Sexual Violence Agency, came together to brainstorm and identify gaps in current approaches to addressing the Hurried Child Syndrome in Lagos State.

Twenty-six individuals attended the first day of the meeting, and twenty-five attended the second day, representing government agencies and professional bodies with a vested interest in the well-being and future of Nigerian children. The meeting concluded with a vote of thanks delivered by Barrister Hanatu A. Enwemadu, the Executive Director of A Mother's Love Initiative.



The focal point of the meeting revolved around A Mother's Love Initiative's (AMLI) comprehensive presentation on the Hurried Child Syndrome and its corresponding intervention plan tailored for implementation within educational institutions. AMLI meticulously outlined issues associated with hurried child practices and underscored the critical need for collaborative efforts aimed at sensitizing both parents and educators regarding the adverse impacts of rushing children through their developmental stages. The presentation also addressed pertinent concerns such as underage enrollment and the imperative for capacity-building initiatives within schools.

Among the significant outcomes of the meeting was the designation of directors tasked with collaboratively mapping out strategies, as well as the allocation of specific responsibilities aimed at providing technical support to AMLI. This collaborative endeavor between AMLI and the Ministry of Education signifies a concerted effort to effectively address the challenges posed by hurried child practices within educational settings and broader society.

OUR PARTNERSHIPS (LAGOS STATE UNIVERSAL BASIC EDUCATION BOARD)



The meeting kicked off with a captivating presentation of AMLi's yearly activity schedule for the Hurried Child Project, passionately underlining the critical need for LASUBEB to align with this transformative initiative. The upcoming 2-day strategic meeting in July was unveiled, promising an enriching exchange of ideas.

In a pivotal moment, AMLi, expressing its passion for basic education and child development, made a heartfelt request for an official approval letter. The atmosphere was charged with positivity as the Chairman and LASUBEB enthusiastically gave their seal of approval for a collaborative journey with AMLi on the impactful Hurried Child Project. The stage is set for a dynamic partnership that promises to make a lasting difference.

OUR PARTNERSHIPS (LAGOS STATE MINISTRY OF HEALTH)



The convened meeting, attended by distinguished representatives from both A Mother's Love Initiative and the Lagos State Ministry of Health, was centered on AMLI's comprehensive presentation of the Hurried Child Project.

Key points highlighted during the presentation included the project's inception in November 2021, followed by its nationwide expansion in November 2022. AMLI's strategic framework, strategically crafted to address the syndrome through research, advocacy, and psycho-social interventions, was emphasized as a focal point of discussion. Additionally, deliberations encompassed potential collaboration and partnership opportunities aimed at enhancing the effectiveness of the initiative.

AMLI's presentation garnered positive feedback, with the Ministry of Health expressing a keen interest in further engagement. This interest underscores a commitment to explore the shared documents for potential avenues of collaboration in the future.



The meeting held on June 30, 2023, at the Lagos State Domestic and Sexual Violence Agency (DSVA), centered on AMLi's collaboration with DSVA to address the Hurried Child Syndrome in Nigeria. AMLi presented the project framework, focusing on integrated strategies covering awareness, education, training, service provision, research, data sharing, advocacy, and policy reform. Existing partnerships with key stakeholders were highlighted, and details about an upcoming three-day strategic meeting were provided.

The DSVA Executive Secretary inquired about collaboration with the Ministry of Education and funding sources, to which AMLi clarified its engagement with the Basic Education Services department and emphasized the importance of collaboration with government agencies.

OUR PARTNERSHIPS (FEDERAL MINISTRY OF EDUCATION)



The meeting with the Director of Senior Secondary Education centered on A Mother's Love Initiative's (AMLI) achievements, challenges, and plans, particularly within the framework of the Hurried Child Project. AMLi emphasized the importance of a courtesy visit to the Permanent Secretary of the Federal Ministry of Education, expressing their commitment to advocating for the well-being and future of Nigerian and African children.

Key highlights included the outcomes of a recent 2-day strategic meeting in Lagos, showcasing stakeholder alignment with the Hurried Child Project. AMLi proposed increased involvement from the Federal Ministry of Education to enhance national awareness, expertise, and visibility. The discussion stressed the necessity for policy review and development, ensuring alignment with child welfare, education, and health, with caution against contradictory policies.

The Federal Ministry of Education team encouraged the sharing of strategic meeting reports and urged the prompt finalization of all registration and documentation processes. The meeting concluded with a commitment to future collaborations, paving the way for sustained efforts to address challenges posed by the Hurried Child Syndrome. The stage is set for ongoing initiatives to safeguard the well-being and future of children in Nigeria and Africa.

The meeting was led to discuss A Mother's Love Initiative's project framework, focusing on addressing the Hurried Child syndrome in Nigeria. Adverse childhood experiences were explained, emphasizing their impact on children in Lagos State. Discussion points included intervention indicators and plans for developing training manuals.

Concerns regarding the term "growth" were clarified, highlighting the importance of natural development. The need to understand a child's physiology was underscored. Collaboration with the Ministry of Education, particularly concerning the pre-nursery curriculum, was addressed, along with plans for engaging private schools through their associations.

The overarching objective is to educate parents, teachers, and communities on allowing children to develop at their own pace. Tasks were assigned to align with the ministry's annual operational plan. The meeting concluded with a clear path for collaborative efforts in tackling the Hurried Child syndrome.
